ACCESS AND OPPORTUNITY

We like to think a rising tide lifts all boats when it comes to the economy. But that assumes you have a boat. Many of our Gulf Coast neighbors have missed out on the rebound of our regional economy because they never really had access to it in the first place. Whether they work in low-wage jobs or live on fixed incomes, they see threats like homelessness, hunger, or financial distress not as future risks, but as real and present dangers.

Our Financial Sustainability Initiative-a partnership with United Way Suncoast, the Charles & Margery Barancik Foundation, and others-is one strategy to enable and expand opportunity for current residents and the next generation. Through it we have increased families' financial literacy and opened a door to the banking system. Through goal-setting, expanded knowledge, and real support from their community, these once-struggling parents are transforming their lives...and their children's futures.

The future is as bright as our next generation makes it—wherever they choose to do so. We want them to see their hometown as a no-brainer.

WE SEE DIGNITY **AND HOPE**

That's why Gulf Coast is working with more than a dozen nonprofit partners and donors to implement a system of coordinated services specifically for them. We reduced the number of homeless families in our community through the Family Haven Alliance, and these often invisible youth must get the same level of care. By providing the specialized help they need while recognizing the trauma they have endured, we will provide a pathway to independence and encourage the sense of purpose they deserve.

"I wish life came with instructions. I never had a mentor, my parents weren't around, and I had to grow up at a very young age."

Through our successful Homeless Children and Families initiative, we learned about another underserved group with unique needs in our community-16- to 24-year-olds who are homeless and on their own. The uphill climb faced by these teens and young adults with no permanent home defies all that we hope and expect for our community's youth. Their numbers may shock you: There are over 400 of these unaccompanied homeless youth in Sarasota County. But the real jolt is delivered once you get to know these young men and women and their own hopes and dreams.

THE LONG VIEW

Gulf Coast reached new milestones for grants awarded, gifts received, and total assets by the end of our 2017 fiscal year.

Last year's records are a tribute to our growing family of donors. From July 2016 to June 2017, Gulf Coast and our donors invested \$34 million in grants, initiatives, and scholarships. We also accepted nearly \$37 million in new contributions. This generous giving will fund new ideas and urgent initiatives in the coming year while we also assist our donors in supporting important causes locally and around the world. Meanwhile, with strong investment returns of 13.8% on our endowment, Gulf Coast closed the year with over \$295 million in total assets.
